## **2025-2026 Title I School-Level Parent and Family Engagement Policy**

### 2.1 Involvement of Parents in the Title I Program

Woodbury provides parents opportunities for regular meetings to formulate suggestions and to participate in decisions relating to the education of their children and respond to any such suggestions as soon as practicably possible. Our school holds a flexible number of meetings at varying times, and provides transportation, childcare, and/or home visits, paid for with Title I or other funding as long as these services relate to parental involvement.

Woodbury Elementary School utilizes our School Site Council (SSC) to jointly develop and publish the School Parent and Family Engagement Policy and to plan, review, and revise our School Plan for Student Achievement (SPSA). In addition, our SPSA has been developed with the review, certification, and advice of the school English learner advisory committee (ELAC). Our SSC is comprised of representatives from each stakeholder group as required in EC Section 65000[c][1] and follows the meeting requirements and procedures set forth in EC Section 35147.

- d) The school provides parents of participating children with the following:

- i. Timely information about the Title I program. (20 U.S.C. § 6318[c][4][A])

Woodbury Elementary convenes an annual meeting to inform and distribute to parents the School Parent and Family Engagement Policy and information about Title I school programs, including: their child's and/or school's participation in school programs; the requirements of the school programs; and the parent's rights to be involved. Our annual meeting is held at the beginning of each school year.

- ii. A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging state academic standards. (20 U.S.C. § 6318[c][4][B])

Woodbury Elementary provides parents a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet. Our school, with the assistance of the district, provides assistance to parents of children served by the school in understanding topics such as the following: a) the State's academic content standards; b) the State's student academic achievement standards; c) the State and local academic assessments including alternative assessments; d) the requirements of Title I (if applicable); e) how to monitor their child's progress; and f) how to work with educators. These opportunities are shared with parents through Back-to-School

- Night, individual parent-teacher conferences, on our school's webpage,
- iii. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible. (20 U.S.C. § 6318[c][4][C])

Woodbury Elementary staff and administration encourage all parents to contact the administration if they have suggestions, questions, or would like to make comments regarding programs and activities or their child's progress. In addition, parents have the opportunity each school year to complete the District parent survey which is disaggregated by site. Information from the survey is used by site administration and SSC to help make decisions.

- e) If the schoolwide program (SWP) plan is not satisfactory to the parents of participating children, the school submits any parent comments on the plan when the school makes the plan available to the local educational agency (LEA). (20 U.S.C. § 6318[c][5])

Woodbury submits to the district Office of K-12 Educational Services any parent comments if the SPSA is not satisfactory to them.

## 2.2 Building Capacity for Involvement

To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, each school and local educational agency assisted under Title I, Part A shall carry out the following requirements: (20 U.S.C. § 6318[e])

In addition, the school offers parent education training: 10 Education Commandments and 40 Developmental Assets.

- c) The school educates teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school. (20 U.S.C. § 6318[e][3])

Woodbury Elementary administration, teachers, and staff spend time during the opening staff meetings each year to discuss and plan parent engagement strategies as well as strategies for fostering effective parent communication and ways to engage parents in understanding and making decisions regarding their children's academic progress.

- d) The school, to the extent feasible and appropriate, coordinates and integrates parent involvement programs and activities with other federal, state, and local programs, including public preschool programs, and conducts other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children. (20 U.S.C. § 6318[e][4])

School administration collaborates with District Parent and Community Outreach staff to ensure that the parent support being provided by Woodbury Elementary School is appropriate and that the site has all resources necessary. In addition, Woodbury Elementary staff direct parents in need to one of the District's five Family Resource Centers (FRCs) which serve as hubs for families and students across the district to access critical services in

areas like food, health care, housing, mental health counseling, immigration counseling, victim assistance, and more.

- e) The school ensures that information related to school and parent programs, meetings, and other activities is sent to parents of participating children in a format and, to the extent practicable, in a language the parents can understand. (20 U.S.C. § 6318[e][5])

Woodbury Elementary notifies parents about the School Parent and Family Engagement Policy in an understandable and uniform format and, to the extent practicable, distributes this policy to parents in a language the parents can understand (for languages exceeding 15% of the school population, information is provided in those languages). The school makes the School Parent and Family Engagement Policy available to the local community, by placing it on the school's website and through the front office.

- f) The school provides such other reasonable support for parental involvement activities under this section as parents may request. (20 U.S.C. § 6318[e][14])

Parents are encouraged to seek assistance and support as necessary by contacting the school community liaisons and school administration in the school office, and are provided the opportunity to suggest programs and support activities on the annual strategic plan survey.

## 2.3 Accessibility
